  4. In CV, all the academic and activity done in Academic Year from November, 2020 to October, 2021 should be mentioned.

### **SUBMISSION FORMAT:**

- a) The language of the CV should necessarily be restricted to English.
- b) Format- The submission of the CV should be made in MS Word/ doc/docx. The submissions must be in Times New Roman, Size 12 with 1.5 Line Spacing.
- c) The CV must include: Name, College Name, Email Address and Phone Number otherwise the submission shall be discarded.
